Major Organizational Restructuring and Transfer of Personnel (as of April 1, 2008)

Kuraray Co., Ltd. today announces a decision to implement a major organizational restructuring and transfer of personnel as of April 1, 2008.

Further organizational restructuring measures and personnel transfers (within divisions or sections) as of April 1, 2008, will be announced at a later date.

1. Restructuring Policy

With the closing of its GS-21 medium-term business plan imminent, Kuraray decided on and announced the transfer of a number of executives, including the Company president, to take effect either in January 2008 or as of the date of this announcement. The changes are aimed at preparing the new management execution structure to wind up GS-21 plan activities and to establish and implement a new medium-term business plan targeting further growth.

Meanwhile, Kuraray is focusing on organizational continuity, and the organizational restructuring scheduled to come into effect April 1, 2008 should have a minimum impact on the Company's business operations and will primarily focus on accelerating operations based on management decisions. Kuraray will implement the following organizational changes and personnel transfers to reinforce the corporate structure established through the previous year's restructuring in order to speed the creation of new businesses as well as to apply the beneficial results of activities undertaken in the previous fiscal year.

2. Details of Organizational Reform

(1) Accelerate business operations based on management decisions

In pursuit of management efficiency and the creation of financial and information strategies, Kuraray decided to set up a Corporate Management Division, an Accounting and Finance Division and an Office of Public Relations under the direct supervision of the president in addition to an Office of the Secretariat, an Office of Internal Auditors and an Office of Corporate Strategy and Planning.

(2) Enhanced information strategy

In line with management strategies aimed at boosting the Kuraray Group's recognition through aggressive public relations activities, the Investor Relations and Public Affairs Division shall be spun off from CSR Headquarters to become the Office of Public Relations under the direct supervision of the president.


(3) Entrenchment of internal control system

In order to consolidate the Groupwide internal control system, Kuraray has completely disbanded the Internal Control Reform Team, which was set up to establish said system, transferring the team's functions to the Office of Internal Auditors, which will handle the system's implementation and any related follow-ups thereto.
